### Synod Stated Meeting Metairie Ridge Presbyterian Church | New Orleans, LA November 5-6, 2024

<u>Welcome & Introductions</u> –Synod Moderator Ben Davidson called the meeting to order at 1:30 p.m. CT, opening the meeting with prayer.

Acknowledgement of Land & People – Loretta Credo, member of Metairie Ridge Presbyterian Church, acknowledged the Native American peoples who lived on the land that is now called Metairie. Historical inhabitants of Metairie area included the Chitimacha Tribe, with Atakapa, Caddo, Choctaw, Homa and Natchez Tribes inhabiting Louisiana. Loretta also noted that PC(USA) leaders met with leaders of the Pointe au Chien Tribe on the day before the Meeting. Isabel S. Reivera-Velez, Commissioner, also mentioned the ancestral homelands of the Alabama Coushatta, Anadarko, Biloxi, Caddo, Chickasaw, Karankawa, Kichai, Muskogee, Shawnee, Tawakoni, and Tonkawa. We declare our respect for these children of God and our desire to honor them and the truth of their lives and history.

**Roll Call & Declaration of Quorum** – In accordance with the Bylaws, Sec. 3.1.3 whereby 50% or more of the elected commissioners constitutes a quorum, a quorum was declared by Synod Leader/Stated Clerk Mitch Miller. 17 of 28 Commissioners were present (*Attachment A*).

<u>Seating of Corresponding Members & Visitors</u> – Corresponding Members and Visitors were also acknowledged and seated. Seth Saathoff moved and David Watson seconded that the Corresponding Members and visitors by seated and given privileges of the floor. Motion carried.

<u>Adoption of the Agenda</u> – With the meeting agenda presented, Stacy Clopton moved and Ron Fike seconded that the agenda be adopted. Motion carried (*Attachment B*).

<u>Approval of Minutes</u> – Moderator Davidson presented the minutes from the previous Synod Assembly on February 27, 2024, for approval. Without any additions or corrections, approval of the minutes for the Stated Meeting on October 2022 were moved by Seth Saathoff and seconded by David Watson. Motion carried (*Attachment C*).

**Synod Leader/Stated Clerk Report** – Synod Leader Mitch Miller reported to the Assembly. He reported that it has been a busy few months since our last meeting and he has visited quite a few of the Presbyteries since becoming the SL/SC. (Attachment D).

**Synod Moderator Report** – Moderator Ben Davidson reported to the Assembly, telling the stories of serving as Moderator for 2024. Ben highlighted that the Synod has been responding to its call during the transition to our new SL/SC, going with the strengths that we have.

Highlights of 2024: Calling Mitch Miller as our Synod Leader/Stated Clerk

We committed to increase our support of SPDR. We committed to increase support of the Hispanic Mission Ministries Network. We committed to support our smaller congregations with lay leadership. We committed to increase our support of the Synod Youth Workshop and the Grants and Scholarship Commission.

We are going to move forward with a Border Ministries Network.

<u>Coordinating Team Report</u> (*Attachment E*) – Coordinating Team Moderator Seth Saathoff reported on actions taken by the CT on behalf of the Synod. Conducting the business of the Synod between gatherings, the CT took action to onboard the new SL/SC, worked on the Synod finances with Bill Wiles, committed to the continuing support of the three Oklahoma presbyteries as they discern their future together, planned this Assembly, and served as the de facto Nominating Committee.

**Personnel Committee Report** – Committee Moderator David Watson reported to the Assembly. Personnel is moving forward to the hiring of a part-time Administrative Assistant and providing help for SPDR. A group has been put together to interview the candidates and will move forward.

**<u>Committee on Representation Report</u>** (Attachment F) – Committee Moderator Minwoo Kim reported on behalf of the committee. The focus of the committee has been on communication. Communication between the Korean and Hispanic congregations and the Synod, with the suggestion that the Synod be more proactive in providing translation for Synod functions. Minwoo reported that the committee has only four of the needed six people and are seeking additional members.

**Empowering Committee Report** – Committee Moderator River-Velez reported on behalf of the Committee. Isabel reported that Empowering supports the Network for Dismantling Racism, the Hispanic Missions Ministry Network, Synod Youth Workshop, and is working to the creation of a Border Ministries Network.

Commissioner Leah McFaddin reported on Synod Youth Workshop (*Attachment G*), highlighting an increasing attendance and scholarships presented.

Commissioner Carlos Baladez and Lisa Almon reported on the work of the Hispanic Missions Ministry Network, highlighting the HMMN Leadership Workshops taking place throughout the Synod and via streaming.

Commissioner Kristy Rodgers reported on the Network for Dismantling Racism, mentioning that the Network continuing with its mission under new challenges. This includes a partnership with

Rev. Jermaine Ross Allen with the PCUSA's newly created Center for Repair of Historical Harms to gather our stories and historical harms and share them broadly.

<u>Connecting Committee Report</u> – Committee Moderator David Watson reported to the Assembly. David reported that the work of the Committee centers around the Covenant Partners, including Austin College, who will renew their Covenant Agreement with the Synod at this Assembly.

**Equipping Committee Report** (Attachment H) – Committee Moderator Kristy Rodgers reported on behalf of the Committee. Focusing on creating Elder Training and Suicide Prevention Training, the Committee is looking forward to contributing to our upcoming Synod School.

### **Commissions/Entities**

**Grants and Scholarship Commission Report** (*Attachment I*) – Commission member Lisa Almon reported on behalf of the Commission. Lisa reported that the Commission gave out over \$92k in 2024. She also reported that there are a number of openings in the committee.

**Synod Partnership for Disaster Response** (Attachment J) – In the absence of Kathy Lee-Cornell, Director of the Synod Partnership for Disaster Response, Moderator Davidson reported on SPDR. Ben talked about the amazing work of SPDR and how well it is received throughout the Synod and the Assembly watched a presentation about the Liaison Program. SL/SC Miller reported on the great need for disaster preparation and recovery, with 1/3 of all disasters in the US in 2023 occurred in the Synod of the Sun. Mitch reminded the Assembly that we are in the final year of the three-year program and that it is important that this program continue on beyond that initial commitment.

Oklahoma Tri-Presbyteries Report – Corresponding member Tim Blodgett, General Presbyter of Eastern Oklahoma Presbytery, reported on the work of the Oklahoma Presbyteries Task Force. This group has been about the work of discerning and designing a plan to create a new Oklahoma presbytery. In many ways, the three presbyteries have already begun living in ministry together in programs in ministry.

<u>Nominations</u> – Moderator Davidson introduced Commissioner Ron Fike from Cimarron Presbytery to be the Vice-Moderator of the Synod in 2025. By unanimous vote, Ron was elected Vice-Moderator.

<u>TPF Update on Funds Investment</u> – Rick Young, President of the Texas Presbyterian Foundation spoke about the mission and ministry of TPF, the dangers of "not asking" and about the gift of legacy gifts. Celebrating their 50<sup>th</sup> year, TPF offered to each presbytery to pay for one of the meals at a Presbytery meeting.

**Presentation of the 2025 Preliminary Budget** (*Attachment K*) – Treasurer Bill Wiles presented for consideration the 2025 Budget. Bill opened with the idea of bringing a Joe Park from Horizons Stewardship to the Synod to talk about how we maximize giving. Bill took the Assembly through the budget with a new format.

On behalf of the Coordinating Team, Moderator Davidson moved the approval of the budget. The budget was approved.

Signing of Covenant Agreement (Attachment L) – Connecting Committee Moderator David Watson and Austin College Senior Associate Vice President Suzanne Crouch presented the renewal of a Covenant Agreement with Austin College. After signing the agreement, Suzanne spoke of how Austin College continues the Covenant made at a child's Baptism. Thanks to a generous gift, Suzanne reported that Presbyterian students can attend Austin College tuition-free.

Installation of 2025 Moderator – In the space of worship, Commissioner Sharon Curry was installed as the 2025 Moderator of Synod of the Sun by the Rev. Alonzo Johnson, the Coordinator for the Self-Development of People program.

Following her installation, Sharon shared her vision for the Synod in 2025, redefining the many roles that we have, take a good look at our structures and discern where God is taking us to next. Sharon extended an invitation for the members of the Assembly to decide in what manner they would like to serve in the coming year. Sharon wants to restart our Commissioned Pastors Network and rebuild the Grants and Scholarship Commission.

With the Assembly's business concluded in prayer, the meeting was adjourned.

### Synod Stated Meeting Presbyterian Mission Center | Irving, TX February 27, 2024

<u>Welcome & Introductions</u> –Synod Moderator Ben Davidson called the meeting to order at 1:00PM CT, opening the meeting with prayer.

<u>Acknowledgement of Land & People</u> – Vice Moderator Sharon Curry spoke of the Native American tribes that inhabited the land that is now Irving, Texas, offering a prayer of reconciliation and forgiveness.

**Roll Call & Declaration of Quorum** (*Attachment A*) – In accordance with the Bylaws, Sec. 3.1.3 whereby 50% or more of the elected commissioners constitutes a quorum, a quorum was declared by the Bridge Interim Synod Leader/Stated Clerk Steve Shive. 21 of 28 Commissioners were present.

<u>Seating of Corresponding Members & Visitors</u> (*Attachment A*) – Corresponding Members and Visitors were also acknowledged and seated. Seth Saathoff moved and David Watson seconded that the Corresponding Members and visitors by seated and given privileges of the floor. Motion carried.

**Adoption of the Agenda** (*Attachment B*) – With the meeting agenda presented, Polly Williams moved and Seth Saathoff seconded that the agenda be adopted. Motion carried.

**Approval of Minutes** (*Attachment C*) – Moderator Davidson presented the minutes from the Fall 2023 Synod Assembly, for approval. Without any additions or corrections, approval of the minutes for the Stated Meeting were moved by Seth Saathoff and seconded by David Watson. Motion carried.

<u>Introductions</u> – Synod Leader Steve Shive invited each participant to introduce themselves. A total of 56 participants attended this Assembly.

**Worship** – A contemplative worship experience was led by the Rev. Christopher Lee, Executive Presbyter of Grace Presbytery in the chapel of the Presbyterian Mission Center.

**Synod Focus** – Moderator Davidson outlined his vision for the 2024 year. Reading from two passages of the Gospels, Ben spoke of the great need in the world and the missions of the Synod that meet those needs. Ben encouraged the missions, ministries, and program to seek where the Spirit is leading us, taking bold steps.

<u>Celebration of Solar Under the Sun</u> (*Attachment D*) – Celebrating the transition of Solar Under the Sun from being a Network of the Synod to being a Covenant Partner. Steve Shive told the

story of Solar and gave thanks for this continuing ministry. Inviting board members forward, these friends talked about the mission and ministry and future of Solar Under the Sun.

**Nominations** – Moderator Davidson presented a list of names submitted by the Pan American School for their Board of Directors and Evergreen Life Services submitted a name to serve as their Synod Liaison:

Pan American School – Lemuel Garcia-Arroyo, Diana Freeman, Elizabeth Sinnet David Watson moved and Sharon Curry seconded that these names be approved by Assembly. Motion carried.

Evergreen Life Services – Jim Freeman

Polly Williams moved and Sharon Curry seconded that Jim Freeman be approved by Assembly. Motion carried.

**Approval of 2024 Budget** (*Attachment E*) – Coordinating Team Moderator Seth Saathoff and Treasurer Bill Wiles outlined the changes from the Preliminary Budget approved at the Fall 2023 Assembly. Bill also described the job of a Treasurer as not a gate-keeper, but as a partner in bringing resources together for the ministry of Jesus Christ. Bill reported our pros and cons for 2024:

Our Pros: The synod is financially sound, we have sufficient resources to do ministry, and we have an enthusiastic leadership.

Our Cons: We have a drop in giving from the Presbyteries and we have lots of places where we could be using our funds.

The Coordinating Team moved the acceptance of the 2024 budget. The motion passed.

<u>**Overtures to General Assembly**</u> (*Attachment F*) – Moderator Davidson presented the first Overture from Palo Duro Presbytery to GA to amend the Book of Order G-2.1002. Executive Presbyter Scott Campbell spoke to the concurrence. Sharon Curry moved and Seth Saathoff seconded that Synod of the Sun concur with this Overture. The motion passed.

Moderator Davidson presented the second Overture (*Attachment G*) to provide the list of counties of the geographic areas of each presbytery. Sharon Curry moved and Polly Williams seconded the motion. The motion passed.

<u>Election of the new Synod Leader/Stated Clerk</u> (*Attachment H*) – Rev. Jeff Cranton, Moderator of the Synod Leader/Stated Clerk Search Committee, presented his report. The Committee nominated the Rev. Michell Miller for this position. The terms of call were discussed. Questions from the Assembly were asked.

The Search Committee moved that Mitch Miller become our new Synod Leader/Stated Clerk. With great thanksgiving, the motion carried.

With gratitude, Jeff Cranton moved that the Search Committee be dismissed. The motion carried.

With the Assembly's business concluded, the Assembly gave thanks for the ministry and mission of Steve Shive in his time with us. With closing prayer by the Moderator, the Assembly goes forth doing the ministry and mission given to us by Jesus Christ.

Special Thank You to Rev. Steve Shive for his service as transitional Synod Leader and Stated Clerk until May of this year. We cannot thank him enough for his steady leadership during this time of Transition.

Speaking of transition, we welcome new Treasurer, Bill Wiles to the staff. He has been invaluable as we are in the midst of changing banks and modifying our financial processes.

The search for a part-time Administrative Assistant continues on with the hope that that person will be on board soon. The Administrative Assistant will be the hub for the staff, operating out of the new Synod Office, which will be in the Presbyterian Mission Center in Irving. This is possible only by the gracious (pun intended, yet wholly truthful) invitation of Grace Presbytery to share their space with our future Administrative Assistant and their invitation to hold meetings in their office.

The new Administrative Assistant and the hospitality of Grace Presbytery will allow the rest of the staff to continue to work remotely with greater efficiency.

We are (as of the writing of this report) excitedly expectant with Kathy Lee-Cornell who is currently on maternity leave. Kathy's dedication as Director of the Synod Partnership for Disaster Recovery has continued to pay benefits not only to the Synod's recovery efforts but just as importantly to the task of preparing for disasters both natural and those of human origin. As we prepare to enter the last year of our four-year pilot project, let us be mindful of a couple of important statistics: Over the past 3 years, with Kathy's help we have procured nearly half a million dollars in recovery grants for work within our synod. The Synod of the Sun is only synod, I would remind you, that gets no season off from potential disasters. It is interesting to note as well, that in 1981 there was just 1 natural disaster that was considered a "billion dollar disaster" (that is adjusted for inflation). In 2023, there were 23 "billion dollar disasters" and 1 in 3 occurred within the bounds of the Synod of the Sun.

We are grateful for her work, happy for her well-deserved leave, and very much looking forward to her return to this ever-increasingly important task to which she is called. Please take the time to read her report and make note of all that she has been doing to serve our Synod in difficult times.

As thank you's go, I do not think we could ever over-state what we owe as a synod to the work of our Communications and Administration Coordinator, Thomas Riggs. What he has done to keep the work of Synod going during this time of transition could never be fully calculated, but deserves to be noted and given proper gratitude. Though he has un uphill battle before him when it comes to training the new synod leader, his patience thus far is greater than should be expected. In addition to his work through the transition, his leadership continues to expand the CSS (please note the report) and helps to maintain our synod's reputation for excellence and action.

Due to the timing of our transition, the review of 2023 presbytery minutes by the stated clerks will be postponed to 2025 when we will gather to review both 2023 and 2024 minutes.

# **Coordinating Team Report**

# Fall 2024 Assembly

The Coordinating Team of the Synod of the Sun consists of the Coordinating Team moderator, the elected officers of the Synod, the moderators of the Synod's standing committees, the Executive Presbyter Forum representative, and the Synod Partnership for Disaster Recovery (SPDR) director.

The Coordinating Team is charged with carrying out the business of the Synod in the intervals between Synod Assemblies and does so with all the powers and authority of the Synod Assembly.

Some of the noteworthy action items taken by the Coordinating Team since the Spring 2024 assembly include:

- Some financial considerations concerning Mitch Miller's transition to the role of Synod Leader/Stated Clerk.
- In consultation with the Treasurer, made investment decisions with the Synod's reserve funds.
- Opened new banking accounts with Pegasus Bank.
- Contracted Ratcliff & Associates CPAs to perform a financial review.
- Reviewed and made changes to Synod's travel reimbursement policy.
- Approved a funding request from the three Oklahoma presbyteries to continue working with former Bridge Interim Stated Clerk Steve Shive towards the creation of a new unified presbytery for the entire state of Oklahoma. Steve has been involved in these discussions from the beginning and the presbyteries felt his continued involvement was of paramount importance.
- Planned the Fall Assembly.
- Developed a preliminary budget for the Synod of the Sun, to be adopted by the Assembly.
- The Coordinating Team also serves as the de facto nominating committee. This process is typically led by the Vice Moderator.

Thus concludes my report.

- After selling, both churches agree to donate the money to Guymon Community and Richmond Foundation for flood victims.
- Also, FPC of Guymon delivered leftover food to all Guymon community institutions that work for flood victims and their families.





Conclusion:

- Even though PC U.S.A. and Synod of the Sun have problems with different races and cultural differences, we may find a solution to work together.

- The way of being together is to cooperate with both White and BIPOC churches, not as Supporter and workers. Relationships between the group need to change to partner.
- Movement of change and providing for BIPOC churches are necessary.

# <u>2024</u>

Synod Youth Workshop (SYW) 2024 was a big success. Rev. Josh Robinson was the keynote speaker and the theme was "We Are Enough". The total participation this year was 156, including staff. This is a significant increase from the last two years, when the total was 131. The racial/ethnic percent of attendees was 35%, also an increase from last year. For the first time, a Presbyterian church from Minnesota, on a mission trip in Tulsa, joined SYW for Service Projects Day and Thursday Keynote. There were 24 of them, 19 youth and 5 adults. This was a great addition and brought the number of participants serving the non-profit community in Tulsa to 181. Seven states were represented (Texas, Oklahoma, Louisiana, Arkansas, Missouri, Kansas and Minnesota).

Iglesia Latina in Houston received financial assistance from several sources including Synod of the Sun. This was a huge help in increasing the number of participants and making the conference more ethnically diverse. This congregation had 15 youth and 2 adult participants. They are extremely grateful, as is the Leadership Team of Synod Youth Workshop, for the generosity and collaboration to insure their ability to participate. They are already planning to return in 2025. One of their youth participants will be serving on the 2025 Planning Team.

The success of the conference was seen in all the many pictures, comments and positive evaluations. Another mark of success is the number of Youth Planning Team applications and Small Group Leader applications received for next year's conference.

# <u>2025</u>

Plans are quickly progressing for SYW 2025. The dates are July 14 - 19 at the University of Tulsa.

Rev. Alexandra Pappas is the Keynote Speaker. Alex served as Associate Pastor at FPC Shreveport and recently moved to Georgetown, Texas, where she is Head of Staff at FPC Georgetown. She grew up attending SYW and has also served as a Small Group Leader. Alex will soon be working with youth Planning Team members to develop the theme for 2025.

Nine youth will serve on Planning Team. They represent congregations in Texas, Oklahoma and Missouri.

The SYW Leadership Team is working on scholarship requests in an effort to increase participation with an emphasis on ethnic and geographical diversity. As always, the goal is to provide a safe place for youth to discuss their lives, grow spiritually and feel God's love and acceptance.

Communication Services Plan: This is basically a small business under the stewardship of Thomas Riggs, with the help of Lindsay Freeman-McCarthy, designed to provide reasonably priced communications services (basic website design, newsletters, etc.) to Presbyteries and other entities. (See accompanying report for details)

The team is currently working to identify, curate, and share resources for Elder training and Suicide Prevention. Both issues have been identified by the Presbyteries as needs with which the Synod can help.

For Elder training, the goal is to have information and links to resources readily available on the Synod website for folks in three categories, depending on level of need: Beginner, Competent, or Advanced (for example).

For Suicide Prevention, we have been learning about various programs available and will seek to provide information and links, also on the Synod website.

Specific training may also be provided through Synod School workshops. -----Synod School is being adopted to provide educational opportunities to Presbyteries through group gatherings over a period of three days. The plan is to do one Synod school/year to start, with classes limited to 50 participants each. Workshop topics will be determined by a Synod school planning team consisting of representatives from all four states/multiple Presbyteries.



# Synod Partnership for Disaster Recovery

Synod of the Sun Assembly November 2024 Report

**The SPDR Leadership Group (LG)** consists of Julia Farrell, Presbytery of the Pines (2025), Jim Kirk (2022), Presbyterian Disaster Assistance; Matt Miles (2022), Tres Rios Presbytery; Cheryl Pennington (2024), Indian Nations Presbytery; Richard Williams (2022), Presbytery of South Louisiana; and Mitch Miller (2024), Synod Leader and Stated Clerk, Synod of the Sun.

The LG met in-person in September to approve the 2025 SPDR Budget Proposal as well as to receive a presentation of SPDR Cash Flow Projections through 2028 presented by Synod Treasurer, Bill Wiles. Richard Williams and Bill Wiles will work together to oversee investments of excess SPDR cash in a series of CDs in consultation with Texas Presbyterian Foundation. The LG will meet again on February 17-18, 2025 to develop a proposal for transitioning SPDR from its pilot phase to a sustained program among its current Covenant Partners.

# **SPDR Director's Report**

In 2024, the Synod of the Sun has experienced the following disaster events:

- Arctic Blast: Eastern Oklahoma Presbytery
- Wildfires: Palo Duro Presbytery
- Tornadoes: Arkansas, Eastern Oklahoma, Grace, Indian Nations, and South Louisiana Presbyteries
- Severe Weather & Flooding: Arkansas, Cimarron, Grace, and New Covenant Presbyteries
- Hurricane Beryl: New Covenant and Pines Presbyteries
- Hurricane Francine: South Louisiana Presbytery
- Cyber Attack: Grace Presbytery
- Earthquake: Tres Rios Presbytery
- Church Fires: Indian Nations and Mission Presbyteries

In response to these events, Presbyterian Disaster Assistance has disbursed **\$106,382.86** in financial grants across 7 presbyteries and has deployed **7 National Response Teams** to support presbytery and congregational leaders as they reach out to impacted communities. The Synod of the Sun has disbursed an additional **\$16,520** in disaster grants this year. A total of **\$122,902.86** has been received across the Synod.

In July, SPDR provided an online Hurricane Preparedness Webinar & Tabletop Exercise Event with participation from 8 presbyteries. In September, the SPDR Liaisons Network met for the first in-person retreat and training event at Ferncliff. Video reports, monthly blogs, and podcast episodes have been developed and shared to provide SPDR communication, stories, and education across the Synod.

Kathy will be on parental leave from November 1, 2024 to February 7, 2025. The SPDR Liaisons Network is monitoring potential events and is prepared to activate if/when necessary.

# Synod of the Sun Notes to the 2025 Proposed Budgets

Below are some general notes to assist you in wading through the proposed 2025 budgets for the Synod of the Sun:

- 1. <u>This is a proposed budget</u>. We will know more accurately about our budgeted incomes after the first of the year. The revised 2025 budget will be presented at the Spring Assembly.
- 2. This is a new budget format. There are three major sections to the budget:
  - a. The unrestricted funds or operating budgets (pages 1 through 4).
  - b. The proposed 2025 uses of the Synod-designated reserve funds (5).
  - c. The projected 2025 funds available to the Grants and Scholarship Commission (pages 6-7).
- 3. There are several new and expanded areas of mission and ministry focus in the 2025 budget. Please look specifically at the yellow highlights on page 2.
  - a. Our Synod Leader, Rev. Mitch Miller, is working on a re-launch of the Synod School to provide a forum for learning, sharing best practices, and building personal relationships across the four states of our Synod.
  - b. We are increasing resources targeted at supporting and encouraging Hispanic ministries and their congregations.
  - c. We are placing more emphasis on providing resources to presbyteries and churches across the Synod as they deal with the requirements for increased training in the areas of identifying unacceptable employee behaviors.
  - d. We are providing more resources for the work of the Synod Youth Workshops.
  - e. We are providing more support for the work of the Synod Partnership for Disaster Recovery.
  - f. We are continuing to emphasize grants and scholarships for camps and conferences as faith building opportunities for our youth. We continue to underwrite the costs of preparation for ministry.
- 4. In order to fund these new and expanded mission and ministry efforts, each of our committees and commissions have worked hard to focus their efforts in specific areas rather than the more shot-gun approach budgeted in previous years.
- 5. Lastly, this budget begins a process of looking at our cash reserve and investment funds as sources to augment our annual budgets. We need to be good stewards of the funds entrusted to us investing them wisely and allowing them to grow in value. But we also need to make sure that these funds are used for their primary purpose...proclaiming and witnessing to the Gospel of Jesus Christ. Your Synod leadership team seeks to walk a responsible balance between these two goals.

# A Joint Covenant Partnership Between The Synod of the Sun and Austin College

The Synod of the Sun is a mid-council of the Presbyterian Church (U.S.A.) with historic ties to Austin College which dates to 1849. As an agency that serves congregations of the Presbyterian Church (U.S.A.) in Arkansas, Louisiana, Oklahoma, and Texas, Austin College now seeks to renew its covenant partnership with the Synod of the Sun. The Synod of the Sun serves Christ by connecting, equipping, and empowering Presbyterians for Christ's mission within and beyond the Synod's bounds of Arkansas, Louisiana, Oklahoma, and Texas. Providing leadership development, grants and scholarships, and communications services because we believe when we work together across boundaries, we make visible the Good News and find wholeness as the body of Christ. In our common calling, we impact lives together.

Austin College is a private, residential, co-educational college and is dedicated to educating undergraduate students in liberal arts and science while also offering select pre-professional programs and a graduate teacher program. Founded by the Presbyterian Church in 1849, Austin College continues its relationship with the church and its commitment to a heritage that values personal growth, justice, community, and service. An Austin College education emphasizes academic excellence, intellectual and personal integrity, and participation in community life.

Mutual Understanding and Commitments

A. Mutual Understanding and Support

Both the Synod and Austin College will demonstrate mutual understanding and support for each other.

Continuing communication between the college and the Synod should be maintained and encouraged.

B. The Role of Austin College

In the spirit of collaboration, the College will advise the Synod of comprehensive campaigns, inviting its participation.

C. The Role of the Synod

As part of the formal approval of this Covenant, the Synod authorizes clergy representatives of Austin College to celebrate the Sacrament of the Lord's Supper in accordance with the *Book of Order* of the Presbyterian Church (U.S.A.) as part of the Religious Life Program of the college (see especially W-2.4012b).

The Synod will encourage the use of students, personnel, and facilities of Austin College to carry out the mission and work of the Synod.

The Synod will interpret and advocate the role and programs of Austin College through the Synod and General Assembly-related foundations and publications and will facilitate connections between Austin College and other Synod covenant partners.

The Synod shall continue to support Austin College, its faculty, students and administration with its prayers.

# Formal Approval

This document contains all the terms of the covenant relationship between the Synod of the Sun and Austin College. By formal action, the trustees of Austin College and the Synod of the Sun adopt this covenant and pledge themselves to carry out its provisions.

The original covenant was approved by the Austin College Board of Trustees on November 11-12, 1982; by the General Council of the Synod of Red River and Sun, on November 20, 1982; and officially confirmed at the Meeting of the Synod of the Sun on June 28, 1983. The sixth revision was prepared by the Covenant Review Team, Austin College, Sherman, Texas, on February 23, 2018. This agreement shall be reviewed by Synod and Austin College in September 2028 and shall be renewed in 2029.

The Synod of the Sun and Austin College embrace this joint covenant partnership and agree to mutually support one another's ministries. By signing this covenant partnership, the Synod of the Sun agrees to pray for, advocate on behalf of, and support Austin College as it seeks to respond to the biblical admonition in Isaiah 51:1 "Listen to me, you that pursue righteousness, you that seek the Lord. Look to the rock from which you were hewn, and to the quarry from which you were dug. "The Synod affirms the mission of Austin College and encourages each of its member congregations to pray, advocate, and support Austin College's ministry.

The Synod will provide opportunities for Austin College to share its ministry at Synod gatherings and through its print and electronic communications. By signing this covenant partnership, Austin College agrees to maintain a visible presence in the life of the Synod of the Sun, including their member presbyteries.

This agreement in 2024 is not a legal partnership and the Synod agrees that Austin College may establish and maintain mission partnerships with other agencies and denominations. The Synod and Austin College agree to renew this covenant partnership in 2028.
